NOTICE

Be Careful do not overtighten Plastic parts! Could damage threads or nuts!

The John C Ernst Model T18-324MB-3 Mounting Bracket was designed, once installed, to be easily repositioned after installation.

Installation can be preformed prior or after the installation of the J14 Series Shielded Liquid Level Gauges.


Please follow all installation instructions in the other equipment's Instruction Documentation.

NOTICE


The polycarbonate shield may be cut to the mounting bracket position and reinstalled into the shielded level gauge after the final position has been established. Alternatively, a 3/4" hole may be drilled, then installed through the hole after the final position is determined.

Installation:


1. Slide and remove Polycarbonate Shield.




- 2. Loosen set-screws of mounting bracket.
- 3. Slide mounting bracket on to shield frame to desired level. If bracket does not slide on easily, gently squeeze the frame sides by hand or with pliers.




4. Tighten set-screws of mounting bracket.



- 5. Tread 1 plastic nut loosely on to the proximity switch.
- 6. Pass the proximity switch through the hole on the mounting bracket, as you do this, thread the other Nut to the proximity switch between the bracket and the glass.



7. Ensure the switch is touching the glass, then tighten the plastic nuts.
